**6. Question** - Please confirm that bidders can submit their own Corporate Resolution.

7. Question - Equipment Storage – Spec section mentions the contractor is allowed to dump debris at the Westbank storage yard. How much debris is the contractor allowed to dispose of at this location and will the contractor be required to purchase additional dumpsters? Is this yard fenced and gated? Is this yard large enough to store the minimum required equipment for this contract?

**Answer -** Contractor can dump all debris related to the contract. No additional dumpsters are required. The yard is fenced and gated and large to store the equipment needed for this contract.

- Question Does the current contractor provide street sweeping as required in the current bid specifications?
   Answer Not relevant to this bid.
- **9. Question -** Does the current contract provide Flat Rough mowing with a tractor and rotary cutting attachment? The spec calls for maximum of 3" height for turf, this can be difficult to achieve with a large rotary bushhog. Will a finish-mow type rotary bush hog be required?

**Answer –** Equipment to be determined by the contractor.

**10. Question -** Similar to the question above, is the current contractor adhering to the specifications that all turf must be maintained below 3" height using the 20' boom attachment?

Answer - Not relevant to this bid.
