Questions from the Vendor and State's Responses:

Vendor Question 1. Point of Contact: Name, Email and Phone number?

State's Response: *The point of contact is Jason Bihm, Jason.Bihm@la.gov, (337)550-5662*

Vendor Question 2. Name and address of property?

State's Response: *The name and address of the property is Allen Correctional Center, 3751 Lauderdale Woodyard Rd. Kinder, La. 70648*

Vendor Question 3. Any brand affiliation?

State's Response: *We have no brand affiliation.*

Vendor Question 4. How many rooms/ beds are on site?

State's Response: *This is a correctional facility with 1,608 beds, but this solicitation is only requesting service for 94 TVs.*

Vendor Question 5. Do any rooms have more than 1 TV- call out how many?

State's Response: *There are NO rooms/areas with more than one TV. However, this service is looking for a box and satellite set up in the Admin building, splitters/lines to individual TVs are already in place. All equipment beyond the satellite and Admin building are property of DOC and will not require service from vendor.*

Vendor Question 6. How many common areas are there?

State's Response: *We have 32 common areas, however, this service is looking for a box and satellite set up in the Admin building, splitters/lines to individual TVs are already in place.*

Vendor Question 7. Are the TVs Pro:Idiom (Hospitality grade)?

State's Response: Our TVs are not hospitality grade.

Vendor Question 8. Who is the current provider?

State's Response: Resort Internet is our current provider.

Vendor Question 9. Are there any issues with current provider?

State's Response: No issues with current provider.

Vendor Question 10. What are they currently paying (monthly or per room)?

State's Response: I can't give this information on an active bid.

Vendor Question 11. Is there a budget in place?

State's Response: I can't give this information on an active bid.

Vendor Question 12. What is the timeline?

State's Response: The timeline for delivery should be 60 days after contract is awarded. The contract will begin date of award and will end June 30, 2026. With the option to renew for 4 years.

Vendor Question 13. How many buildings on site?

State's Response: We have eight buildings that need cable, however, this service is looking for a box and satellite set up in the Admin building, splitters/lines to individual TVs are already in place.

Vendor Question 14. How many stories are those buildings?

State's Response: The Admin building/Satellite room, where the vendor will be performing service, is only one story.

Vendor Question 15. Is there current cabling? What type (coax/ cat/ fiber)?

State's Response: Yes, our current cabling is coax.

Vendor Question 16. Are you a non profit organization?

State's Response: We are a nonprofit organization.

Vendor Question 17. What is your internet capabilities?

State's Response: No internet capabilities.
