Vendor Question 1. I have a question regarding #11 on page 4 of Attachment A. The subject in question is "copy of their structural place of business permit". What exactly is that and is it needed?

State's Response: On July 18th 2025, Addendum No. 01 was issued to update the Herbicide/ Pesticide Ground Application) Contractor Requirements. The structural place of business permit is not require from the bid. Please see Addendum No. 01 for more information.

Vendor Question 2. If we come across invasive plants do you want us to spray that too while we are there?

State's Response: Yes, that is fine but keep in mind that the contract is to spray certain tree species (cannot spray Cypress trees).

Vendor Question 3. Will we be allowed to use ATVs and/or Argos to access the sites?

State's Response: Yes, the use of ATvs and/ or Argos is allowed.

Vendor Question 4. Will there be any limitations on using subcontractors?

State's Response: The use of subcontractors is allowed, but the vendor submitting the bid will be required to meet all requirements of the solicitation, including but not limited to insurance and license.

Vendor Question 5. Will this be a lump sum, i.e. one job?
