The following revisions shall be incorporated in and take precedence over any conflicting part of the original contract document:

PART 1 – UNIFORM CONSTRUCTION BID FORMS:

1. For paper sealed bidders, with reference to page UCBF 1 of 4 of Part 1, Uniform Construction Bid Forms, the Bidder shall indicate the receipt of this addendum in the space provided. For online Central Bidding bidders, an acknowledgement of this addendum will be prompted by the electronic bidding program prior to formally submitting the bid. **Failure to indicate the receipt of this addendum shall be cause for the bid to be rejected.**

PART 2 – SPECIAL PROVISIONS AND CONTRACT DOCUMENTS:

1. For paper sealed bidders, with reference to page UCBF 1 of 4 of Part 1, Uniform Construction Bid Forms, the Bidder shall indicate the receipt of this addendum in the space provided. For online Central Bidding bidders, an acknowledgement of this addendum will be prompted by the electronic bidding program prior to formally submitting the bid. **Failure to indicate the receipt of this addendum shall be cause for the bid to be rejected.**

AGREEMENT

1. Revise the Contract Time listed in the Agreement to two-hundred and seventy (270) calendar days.

COMMENTS AND QUESTIONS

1. Can a copy of the as-builts be provided for the structures that are to be demolished?

2. Section 03651 Flowable Fill Spec paragraph 3.03A states that "Before depositing flowable fill, all debris and foreign matter shall be removed from the location." Can "all debris and foreign matter" be elaborated more because we know that some of these lines are large and there are low spots that may not be able to remove all foreign matter by normal construction means. We would like to understand the effort on this so it can be priced accordingly. i.e. is there a flow volume or rate to flush? Is this simply pumping out the lines to low spots as much as possible? We assume there will not be camera or personnel inspections required inside these lines to confirm "all debris and foreign matter" is removed but wanted to confirm.

The Contractor can assume that there is no significant amount of debris in the pipes to be flow filled, and that they are only filled with water. The water shall be pumped up prior to the flow filling operations, and the water is to be discharged into the sanitary sewer system. There will be no camera or personnel inspections required. Flushing and/or cleaning will not be required.

3. Section 999991 Demolition Spec paragraph 3-3A.j states "When existing pipe is removed, the Contractor shall plug the resulting open ends whether or not so indicated. Where removed piping is exposed, the remaining piping shall be blind-flanged or fitted with a removable cap or plug." Since these lines below grade will be filled with flow fill, please confirm that piping caps or plugs will also be required in addition to the flow fill as this will be a costly item if so.

Please refer to the Coastal Protection and Restoration Authority Letter of No Objection (dated 12/16/24) which is included in the attachments of the Specifications. All large diameter underground pipes will be flow-filled and capped to three feet below final grade.

4. Can additional time be added to the duration of the project more than the 180 calendar days listed? We feel that 6 months may not be enough time to demolish all of this work and provide final grading per the plans in that timeframe.

The Contract Time listed in the Agreement has been revised to 270 calendar days.

5. For the wastewater treatment plant demolition, can you tell me how old the facility being demolished is?

There is an exhibit that details the age of each of the buildings and structures on the site attached to this addendum.

6. Would it be possible to revisit the site on Monday Sept 8th, 2025 ?

The site will be made accessible to all interested bidders. The side gate at the Central Wastewater Treatment Plant located at 1104 W McKinley Street, Baton Rouge, LA 70802, will be open and accessible at 9:00 A.M. until 3:00 P.M. each day from Monday, September 8th, 2025 until Friday, September 12th, 2025.

7. As far as the fencing and tree line (brush) scope of work, would you have an idea on how much needs to be repaired because there is limited access to that stuff.

Refer to Section 999991 Demolition, 1-2 Scope of Work, Note G.

8. Regarding the final clarifier that's below grade, if we pulverize the walls and the debris falls down into the tank, can it stay as back fill?

No, Concrete debris is not allowed to be used as backfill material in the below grade structures. For more information, please refer to the conditions of the permits and letters or no objection which are included in the Attachments of the Specifications.

9. It was discussed at the prebid that concrete material can be crushed and left on site? Please confirm that it is acceptable to crush and leave recycled aggregate on site. Does this material need to meet a certain specification, or can it be crushed to a 2" minus?

The use of crushed concrete is allowable per Section 999991 Demolition of the Specifications. The crushed concrete shall be 2" minus or 3" minus, whichever is more cost effective, and free of reinforcing steel.

10. It was discussed at the prebid that some slabs and flatwork can remain in place. Can a marked-up drawing be provided to clearly indicate what can remain and what needs to be removed.

The building slabs, sidewalks, driveways, and pavements that are under or surround the following buildings are to remain:

- Dewatering building
- Maintenance shop
- Administration building
- Warehouse building
- E&I building

All other slabs, sidewalks, and pavements shall be removed.

11. Grading- can the existing grade shots provided on C-1 be re-issued (specifically on the east side and south side of the project). They are not legible on the current document.

12. Please verify the scale on sheets C-1, C-2 and C3. The current 1:60 scale appears to be off based on the dimensions provided in the chart on C-1

The scales on sheets C-1, C-2, and C-3 are correct. It is 1" = 60' on a 24" x 36" sheet.

13. Regarding the 24"-60" pipe outlined in the chart on C-2. Please confirm that these are the LF and approximate volume of pipe that is to be flowable filled (and not that these are to be removed).

Confirmed, the chart listed on sheet C-2 notes the linear footage and approximate volume of pipes to be flowable filled.

14. Does the site need to be seed and fertilized upon completion?

Yes. Seed, fertilizer, and water will be required for disturbed areas as noted in Section 999991 Demolition, 3-1 General, Note G and also noted in the Coastal Protection and Restoration Authority Letter of No Objection which is included in the attachments of the Specifications. Please refer to Section 903 Erosion Control for additional requirements for use of seed, water, and fertilizer.

15. Are any demolition permits required or is that waived since the City of Baton Rouge is the owner?

There are no additional permitting requirements for the Contract. All applicable permits have been acquired by the Owner and are included as attachments in the Specifications.

16. Does all universal waste need to be removed prior to demolition?

Yes, all universal waste needs to be removed prior to demolition. Please refer to EPA Universal Waste Rule (40 CFR Part 273) & LDEQ Universal Waste Rule (LAC 33:V:38) for additional information.

17. Can you provide the latest version of the East Baton Rouge approved SEDBE vendors list?

Yes, the latest version of the list is attached to this addendum.

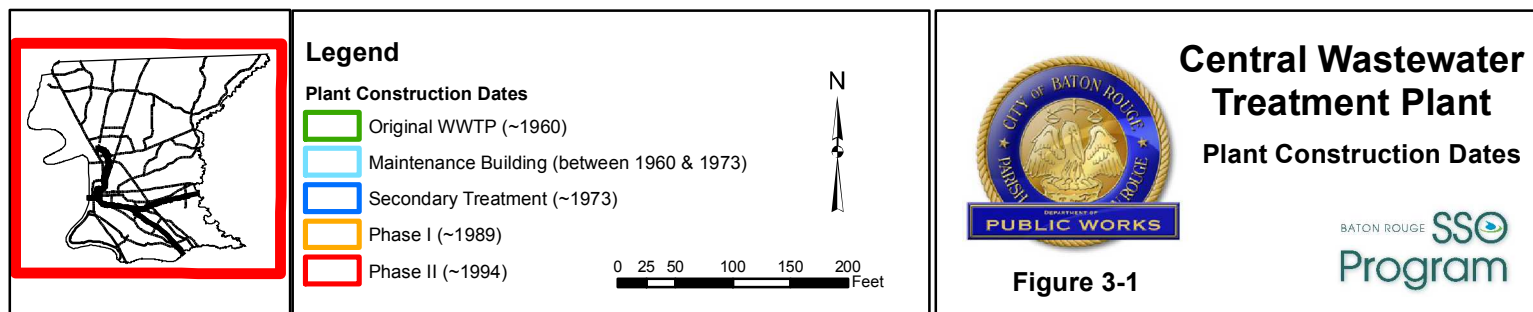
