SPECIFICATIONS:

All Preformed, Heat-Applied, Beaded, Retroreflective, Thermoplastic Pavement Marking, Non-Pre Heated must be in accordance with the requirements of the bid and MS Specification 435-001, Revised 09/14/2023. Failure to meet these specifications will result in rejection.

All white preformed thermoplastic must be an approved material listed on the Approved Materials List (AML) for Preformed Heat-Applied Thermo Striping Material prior to bid opening. All other colors are not required to be listed on the AML nor the NTPEP Test Deck.

QUANTITIES:

This is not an order to deliver. The quantities listed below are estimated usage only. No quantities are guaranteed. Only actual quantities needed will be ordered by DOTD. In the event a greater or lesser quantity is needed, the right is reserved by DOTD to increase or decrease the amount at the unit price stated in the bid.

Line items with a quantity of Three (3) reflects an item that has a history of low usage so it may not be ordered during the life of the contract.

The successful bidder must supply at bid price actual quantities as ordered whether the total of such quantities is more or less than the quantities shown in the RFx.

Bids which specify a minimum delivery will not be considered for award.

GUARANTEE AND LIABILITY:

The contractor accepts the following guarantees:

- (1) Guarantee that the supplies delivered are free from defects in design and construction.
- (2) Guarantee that the supplies are the manufacturer's standard design in construction and that no changes or substitutions have been made in the items listed in this contract.

The contractor holds and saves the State, its officers, agents, and employees harmless from liability of any kind, including cost and expenses on account of any patented or unpatented invention, articles, devices or appliances manufactured or used in the performance of this contract, including use by the government.

The contractor agrees to replace free of charge all defective equipment, materials or supplies delivered under this contract. All transportation charges covering return and replacement shall be paid by the contractor.

Unit price bid must not exceed two digits to the right of the decimal point. Unit price submitted beyond two digits will be rounded off to the nearest second digit.

Must be bid in correct unit of measure shown to be considered for award. Quote submitted in any other unit of measure will not be considered.

At the option of the Department of Transportation and Development and acceptance by the contractor, this contract may be extended for two (2) additional twelve (12) month periods at the same prices, terms and conditions. Contract not to exceed thirty-six (36) months.

Prior to exercising the department's option to extend the contract, the department will determine if an extension is in the best interest of the department, taking into consideration current market trends, cost factors, price comparison with similar service in other states and various other factors as determined by the DOTD procurement director.

The Department of Transportation and Development reserves the right to cancel this contract with thirty (30) days written notice.

All orders delivered prior to the effective date of such termination shall be paid for by the Department in accordance with the terms of the contract, whereupon all obligations of both parties to the contract shall cease.

In the event contract contains a provision entitled "Guarantees" such guarantees shall apply to all items delivered prior to termination.

NOTE: All bidders should furnish descriptive literature with bid. Bidder may be required to furnish literature prior to award.

All bidders should indicate the brand and model number for each line number. If brand and model number is not shown, bid may not be considered for award.

Products are subject to laboratory testing before final acceptance.

Low bidder may be required to submit a sample of product bid. If requested, sample must be furnished at vendor's expense and received within ten (10) days from date of request. Package should be clearly labeled with company name, brand name and number and Solicitation number.

Vendor shall be registered and account active with the Secretary of State office.

PRICES:

Prices quoted shall include all costs incidental to any license or patent that may be held by any company processing the materials bid on and the dealer agrees to hold the Department of Transportation and Development harmless from any claims, suits, costs or penalties for infringement or use of licensed or patented products.

All prices shall be quoted F.O.B. Destination and shall include all freight and/or delivery charges.
BASIS OF AWARD:

Award will be made to the overall low bidder bidding on all items on the RFx. Extended unit prices will be added together to determine the grand total. Line 28 will not be taken into consideration for overall low.

All bidders are expected to complete all pages of the RFx showing the price for each line item and extended unit price. In the event an error is made extending the total unit price, the unit price will govern.

The award of the contract will be made to the lowest responsible bidder complying with all details of this RFx as determined by the DOTD Procurement Director.

Discounts will be taken but will not be a considered in determining low bidder.

DELIVERY INSTRUCTIONS:

The successful bidder will be required to deliver Preformed, Heat-Applied, Beaded, Retroreflective, Thermoplastic Pavement Marking, Non-Pre Heated to all Districts/Sections listed on the District/Section Delivery and Contact information page included in this solicitation and to any other Louisiana Department of Transportation and Development Section or District as required, for the same prices, terms and conditions specified herein.

The successful bidder will be required to have on hand or immediately available an adequate supply of Preformed, Heat-Applied, Beaded, Retroreflective, Thermoplastic Pavement Marking, Non-Pre Heated in order to meet the Department's requirements, as ordered, where ordered, during the life of the contract. Successful bidder should contact the District/Section for accepted delivery days and times at least forty-eight (48) hours prior to delivery. Deliveries are not accepted on weekends, holidays or times of disaster.

Vendors accepting the Cooperative Purchase Agreement understand and agree that deliveries to other State Agencies, Political Subdivisions or Quasi Agencies will be on a statewide basis.

DAMAGE IN SHIPMENT:

Shipments under this contract are F.O.B. destination and title to the goods remain with the contractor until accepted by the Department. However, the Department has a responsibility to report any damage immediately to the contractor. In all cases, a note of damage (except concealed damage) shall be noted on the freight bill at the time the shipment is received by the Department. In all cases where an adjustment is made by the contractor because of damage, the contractor shall issue a credit memorandum to the Department and shall not be required to ship the small quantities which were damaged.

PURCHASE ORDERS:

Purchase Orders will be issued by the Department of Transportation and Development. Each Purchase Order will state the required quantity and all other pertinent data necessary to assist the contractor to make proper delivery. In no event shall delivery be made without proper authorization.

INVOICES:

Upon each delivery and its acceptance by the Department, the contractor shall bill the Department by means of an invoice and such invoice shall make reference to the Purchase Order Number on which delivery was made.

At the time of delivery, the contractor is to provide a delivery receipt on his own form showing complete description and the exact quantity delivered. Such delivery ticket must make reference to the Purchase Order Number.

INSTRUCTION AND TRAINING:

The Contractor shall provide, at no additional cost to the Department, instruction and training services at the various Districts, Sections, or other LADOTD locations, on an as needed, as requested basis. Instruction and training shall be performed by a qualified technician that is either an employee of the Contractor who has been trained by the Manufacturer on the specific materials supplied by the Contractor or is a technician that is employed directly by the Manufacturer. Requests for training will be directed to the Contractor, it is the Contractor's responsibility to provide the personnel. Requestors will not contact the Manufacturer directly for training services.

Instruction shall include, but not be limited to, training films, material application, application equipment operation, proven installation practices, best practice storage procedures to prevent material damage, and any other information critical or useful information as it applies to the Instruction and Training to Preformed, Heat-Applied, Beaded, Retroreflective, Thermoplastic Pavement Marking, Non-Pre Heated materials provided under this contract.

INSURANCE REQUIREMENTS:

Insurance shall be carried by the contractor and a certificate of insurance shall be furnished within ten days after notification. The limits of such insurance shall follow the attached requirements and shall be from a company licensed to do business in the State of Louisiana (see attached insurance requirements).

REJECTION OF BIDS:

The Department of Transportation and Development reserves the right to reject any and all bids and/or waive any informalities.

VENDOR REGISTRATION:
