Following are the Vendors' Inquiries received by the deadline date of September 9, 2025 and the State's Responses:

**Vendor's Inquiry #1:** Can you please advise what specific equipment falls under both Categories I mentioned as per listed in the Contract?

State's Response #1: Per Attachment A – Special Terms and Conditions on page 12 under the Method of Award "The State intends to award Lines 1-4 to the bidder(s) quoting the highest cumulative discount percentage off of the manufacturer's most recent published price list for each brand's categories. The specific equipment that falls under the Categories would be based off of the manufacturer's most recent price list for the brand and category.

**Vendor's Inquiry #2:** My question is although our Company is not listed in the column "The brand listed below are the brands that will be considered" and we have a Riot Gear product for the category listed "Riot Gear" and "Gear and Accessories" can we submit out NIOSH certified E600 Gas Mask for Riot Control?

**State's Response #2:** Per Attachment A – Special Terms and Conditions on page 12 under Proprietary Bid "In accordance with La R.S. 39:1655, Lines 1-16 have been approved as proprietary and only the Brand(s) and Number(s) specified will be considered for award."

**Vendor's Inquiry #3:** If we submit this bid through the portal, will this require wet signatures, or can we sign with an authorized digital signature?

**State's Response #3:** Per the Instructions to Bidders on page 3, number 3 of the RFx it states, "This bid is to be manually signed in ink or submitted online via the vendor portal, whichever is applicable."

**Vendor's Inquiry #4:** Are we required to declare days ARO and if so, where do you want us to report these?

**State's Response #4:** The delivery days After Receipt of Order (ARO) are to be entered on Number 5 under "QUESTIONS TO BE COMPLETED BY VENDOR" on page 1 of the RFx.

**Vendor's Inquiry #5:** Can you confirm which line items in table 2 of Attachment B can have substitute items as long as we preserve "as equal"?

State's Response #5: Line 17 can have an "or equal" product submitted.

**Vendor's Inquiry #6:** Can you confirm if any line items in table 2 of Attachment B can be no bid?

**State's Response** #6: Per Attachment A – Special Terms and Conditions on page 12 under Method of Award, "Stand Alone Accessories (Lines 5-17) will be awarded by line to the lowest responsive, responsible bidder(s) meeting the specifications.

**Vendor's Inquiry #7:** Can you confirm if we no-bid table 1, can we still bid table 2 in Attachment B?

**State's Response** #7: Per Attachment A – Special Terms and Conditions on page 12 under Method of Award, "Stand Alone Accessories (Lines 5-17) will be awarded by line to the lowest responsive, responsible bidder(s) meeting the specifications. The State reserves the right to reject any individual line or category from the award."

**Vendor's Inquiry #8:** Can you clarify the bid acceptance window?

State's Response #8: All bids must be submitted before 10:00 AM CST on September 23, 2025.

**Vendor's Inquiry #9:** Can you provide clarity around your definition of bulk packaging per the packaging clause in Attachment A, page 5?

**State's Response #9:** Per Attachment A – Special Terms and Conditions on page 5 under the packaging clause "Quantities per package which are greater than specified may be considered bulk packaging and may be cause for rejection." Each line item in Table 2 of Attachment B is defined using an "each" unit of measurement.
