Item 1 indicates Qty (12) Full Rack w/Stainless Steel Slots

The 3D rendering would suggest that the Qty is (6).

Item 2 indicates Qty (18) 2-Post Addon

The renderings would suggest the Qty is (12). 18 is the correct

It would appear that the remaining 6 items are Half Racks (located adjacent to the turf)

Item 3 indicates (6) Lat Pulldown w/Low Row Attachment, 250 lb stack.

The renderings would suggest the Qty is (12)

Item 4 indicates (6) Single Cable Column Attachment w/200 lb Stack

The renderings do not show these attachments.

I am writing in reference to Bid SB# 7666 – NSU Athletics Weight Room Equipment. Before finalizing our response, I would like to request clarification on a few details to ensure full compliance with the project requirements:

1. Room Size and Layout:

- **Could you please confirm that the room measurements, flooring, and electrical layout provided remain current and accurate?**
- **Since the equipment must fit precisely within the designated space, confirmation of updated dimensions will help us ensure all items align with the requirements of the Strength & Conditioning Department.**
- **Equipment Quantities:**
- **NSU Athletics Weight Room Equipment (SB# 7666) Line Item 50 lists only one (1) set of PowerBlock Pro 125 dumbbells. Given the scale of the facility, this appears unusually low. Could you confirm whether multiple sets were intended?**
- **Additionally, Line Item 2 (Rack System Half Rack Add-ons – Qty 18) appears potentially disproportionate when compared with the available space and other listed equipment. Can you confirm whether this quantity is correct?**

We want to ensure that our bid reflects the actual needs of the University and avoids any discrepancies between the proposal and the project's functional requirements.
