Your reference is directed to RFx Number 3000025395 for the Invitation to Bid (ITB) for the State of Louisiana – Carbon Monoxide Alarms for DPS, which is currently scheduled to open at 10:00AM CT on October 2, 2025.

The following changes are to be made to the referenced solicitation:

Questions from the Vendor and State's Responses:

Vendor Question 1. Will this be a hard wire or battery operating device?

State's Response: *The Attachment B states the Power Source will be a Sealed Lithium Battery.*

Vendor Question 2. The total number purchased will be 1,560 alarms regardless of the budgetary reasons that require 2 line items for the same thing, or is there a chance that, for example, Line 1 could be purchased, but not Line 2?

State's Response: *This is a one-time buy, and it is our intention to purchase all 1,560 alarms; however, this funding is via a grant so the final quantity purchased will depend on the awarded vendor's unit price.*

Attachment A, Page 6 changed to include – Estimated Quantities: These items are being purchased with grant funds. The listed quantities are the expected purchase amount, but quantities are estimated and may vary based on unit price.

Attachment B, Page 1 currently reads: Smoke alarm shall be UL2034

Attachment B, Page 1 changed to read: Carbon Monoxide Alarm shall be UL2034
Six Alarms per box

All else remains as on original Invitation to Bid.
