Changes to Jefferson Parish Bidding Information

The Jefferson Parish Purchasing Department would like to make vendors aware of the following changes that are now effective:

➤ **Additional Requirements for Bid Instructions:**

The Additional Requirements for Bid Instructions have been revised. The numbers correlating with the instructions may not be the same number as past bids. **Please read ALL instructions and bid documents carefully and thoroughly prior to bid submission.**

➤ **Affidavits:**

There is a new affidavit for all bids named "Generic Bid Affidavit". The Public Works Bid Affidavit and Non-Public Works Bid Affidavit are no longer valid. **The "Generic Bid Affidavit" must be submitted with ALL bid submissions.**

➤ **Insurance Requirements:**

Within ten (10) days of bid opening, the apparent low bidder will be required to provide FINAL insurance certificates evidencing the insurance coverages of the subject bid (please refer to each individual bid specifications requirements) to Jefferson Parish which shall name "the Parish of Jefferson, its Districts, Departments, and Agencies under the direction of the Parish President and the Parish Council" as additional insured on the Commercial General Liability and the Comprehensive Automobile Liability policies to protect against negligence by the contractor, as provided by contract.

Failure to provide your certificate of insurance within the ten (10) days of bid opening shall result in the Parish rejecting your bid as non-responsive and moving on to the next apparent lowest bidder.

You may still opt to send in your insurance certificates with your bid submission, however, if the provided certificates are not in FINAL form, if you are the apparent low bidder, then you will still be required to send in a FINAL certificate within 10 days of bid opening.

SPECIFICATIONS

We extend this proposal for a three (3) year contract to cover all labor, sewing equipment, accessories, and incidentals for the inside delivery and set up of the Bernina Q20 Long Arm Quilting Machine with Frame (or equal), Brother PR680 6-Needle Embroidery Machine (or equal), Bernina 335 Sewing Machine (or equal), Sewing Serger – Brother Airflow 3000 Serger (or equal), and Sewing Machine – Juki DU-118IN (or equal) for the Jefferson Parish Library Department.

Section 1.0: SCOPE:

We extend this bid for a three (3) year contract to cover all labor, sewing equipment, accessories, and incidentals for the Jefferson Parish Library Department.

A quantity of sewing equipment, accessories, and incidentals for the Jefferson Parish Library Department to be determined as the need arises over the next three (3) years. Listed on the attached bid is a representative group of sewing equipment, accessories, and incidentals on which vendors will submit bids to determine the award of this bid.

Once a successful bidder is determined, a three (3) year contract will be entered into with the bidder to supply sewing equipment, accessories, and incidentals for the next three (3) years for all items available through the vendor's online catalog and master price list. Prices for items not listed in this bid will be priced at the current catalog price.

New items that are added to the online catalog/master price list will be included in the three (3) year contract.

All prices quoted shall include transportation, delivery, installation/set-up and initial training required, and removal of all packaging, cartons, miscellaneous things associated with the delivery and installation of sewing equipment, accessories.

The successful bidder will include with this bid a link to the current online catalog/master price list or a current catalog and price list of all available items to include items covered on the attached bid.

A quote will be required by the vendor when ordering for the items listed on this bid and vendor's online catalog and will include the make, model, and cost of items of all items.

Quantities listed are for bidding purposes only. Actual requirements may be more or less than quantities listed.

Line Item 0060 – This line item will be used to order items not listed on these bid specifications, but are available through the vendors online catalog/master price list or a current catalog and price list.

NOTE: Line Item 0060 will not be used in the bidding process of this contract.

Upon request Bidder will submit specifications and literature verifying compliance with bid specifications. Failure to provide these submittals upon request will render the bid as non-responsive.

Section 2.0 Training and Support

- Must include two (2) user manuals and access to manufacturer-provided tutorials for each piece of sewing equipment, accessory, and incidentals
- Manufacturer must offer phone, online, and/or in-person support
- Vendor must offer installation assistance and initial training session (virtual or on-site)

Section 3.0 Transportation and Delivery

This bid will include the transporting of the sewing equipment, accessories, and incidentals to the library facility listed on the quote. Once a purchase order has been issued, the vendor and library representative will set up a date and time for the delivery of the sewing equipment, accessories, and incidentals. All debris, packing materials and cartons, shall be cleaned up and hauled off the premises by the vendor.

SECTION 4.0: SEWING EQUIPMENT

Section 4.1 - Bernina Q20 with Frame (or equal)

Machine Head:

- Throat space: Minimum 20 inches
- Stitching speed: Minimum 2,200 stitches per minute
- Adjustable stitch regulation (BSR or equivalent) with manual and regulated modes
- Color touchscreen interface (minimum 4-inch display)
- Integrated LED lighting over needle and work area
- Built-in thread tension control
- Needle threader (semi-automatic or automatic)
- Compatible with standard quilting threads and needles

- Low-bobbin indicator
- Integrated bobbin winder

Frame:

- Professional-grade frame (minimum length: 10 feet)
- Adjustable height
- Dual-track or precision rail system for smooth movement

Section 4.2: Brother PR68W-06 Needle Embroidery Machine (or equal)

Embroidery Machine Type:

- Commercial-style, multi-needle embroidery machine
- Minimum 6 needles, capable of threading 6 colors simultaneously
- Single-head configuration

Display and Controls:

Integrated large color LCD touchscreen display, minimum 8 inches diagonal

- Touchscreen must support:
 - On-screen editing (rotate, resize, mirror, group/ungroup, color sorting)
 - On-screen letter editing
 - Color preview before stitching
 - Real-time stitch progress display
- Built-in tutorial and help system accessible from the touchscreen

Embroidery Area:

- Minimum embroidery area of 8" x 12"
- Support for multiple frame sizes, including hat/flat/tubular

Connectivity:

- Built-in wireless (Wi-Fi) capability
- USB port for direct design import from USB drive
- Ability to connect to a PC or cloud-based design management system
- Machine must support wireless design transfer and wireless LAN network for file sharing, machine updates, and remote status monitoring

Included Design Features:

- Minimum of 100 built-in embroidery designs
- Minimum of 18 pre-installed fonts, including script, serif, and sans serif options
- Ability to import additional designs via USB or network

Sensors and Automation: Automatic needle threader

- Thread break sensor with automatic stop and alert

Section 4.3 Sewing Machine: Bernina 335 (or equal)

Machine Type:

- Computerized sewing machine with a compact free-arm design
- Domestic/commercial hybrid build quality with metal internal frame
- Compact size with sewing space to the right of the needle of at least 6.3 inches
- CB Hook System for high-precision, high-quality stitches
- Metal internal frame and durable construction for longevity and stability.
- Weight between 15–20 lbs. for stable sewing yet portable enough for makerspace storage

Included Design Features:

- Minimum 221 built-in stitch patterns, including:
 - Utility stitches, decorative stitches, stretch stitches, and quilting stitches
 - At least 1 automatic buttonhole program
 - Monogramming alphabet
- Maximum stitch width of 5.5mm and length of 5mm
- 9 needle positions for precise stitching
- Semi-automatic needle threader integrated into the machine.
- Adjustable thread tension with manual fine-tuning (no fully automatic tension system).
- Drop-in or front-load bobbin system with visible bobbin window.
- Adjustable presser foot pressure for handling lightweight to heavy fabrics

Controls and Display:

- LCD screen for stitch selection and customization.
- Direct selection buttons for commonly used stitches.
- Memory function for storing customized stitch combinations.
- Start/Stop button for sewing without foot control.
- LED sewing light over needle area with no shadows.

Accessories:

- Must include:
 - Hard carrying case.
 - Accessory tray or box.
 - Minimum 5 bobbins.
 - Cleaning tools (brush, oil) and screwdriver
 - Printed or digital user manual

- Includes at least 6 presser feet:
 - Reverse pattern
 - Overlock
 - Zipper
 - Blind hem
 - Buttonhole
 - Button-sew-on

Warranty:

- One-year manufacturer's warranty to include labor, defects, and parts

Section 4.4 Sewing Serger: Brother Airflow 3000 Serger (or equal)

Threading and Thread Capacity:

- Must feature an electronically powered, one-touch air threading system for both upper and lower loopers
- Threading process must use an internal air pump activated by a switch or button, not a manual pump or lever.
- Threading path must be fully enclosed and protected.
- Must support 2-thread, 3-thread, and 4-thread overlock stitching configurations.
- Must offer automatic threading guides with color-coded, numbered threading paths for ease of use.

Stitch Variety, Width, and Speed:

- Minimum of 7 stitch types, including:
 - 4-thread overlock
 - 3-thread overlock
 - 3-thread narrow overlock
 - Rolled hem
 - Flatlock
 - Narrow hem
 - Decorative edge
- Adjustable stitch width from 5.0mm to 7.5mm
- Machine must be capable of sewing at a minimum of 1,300 stitches per minute.
- Machine must operate quietly and smoothly without vibration at full speed.

Include Design Features:

- Must include snap-on presser feet and adjustable presser foot.
- A differential feed ratio of 0.7 to 2.0.
- Feed must be adjustable via external dial or slider.
- Must include adjustable cutting blade with the ability to disengage or retract the knife.
- Trim trap for fabric waste collection.
- Free-arm capability for sewing sleeves or tubular items
- Work area offers at least 4 inches of clearance to the right of the needle

Machine Type:

- Weighs not more than 15lbs for ease of portability
- Maximum dimension 13 inches width by 11 inches height by 11 inches deep.
- Machine must include LED lighting over the presser foot and sewing area.
- Operates on 110V-120VAC

Accessories:

- Includes at least 3 presser feet:
 - Standard overlock foot
 - Blind hem foot
 - Gathering foot
- Must Include:
 - Soft cover or dust cover
 - Foot control and power cord
 - Thread nets and spool caps
 - Tweezers and cleaning tools

Warranty:

- One-year manufacturer's warranty to include labor, defects, and parts

Section 4.5 Sewing Machine: Juki DU-1181N (or equal)

Machine Type:

- Industrial, single-needle, straight-stitch sewing machine equipped with a walking foot system (alternating top and bottom feed mechanism)
- Capable of sewing light to medium-heavy materials including canvas, vinyl, denim, and leather
- Capable of reverse stitching for reinforcing seams

- A servo motor for quiet, energy-efficient operation. Machines with clutch motors or noisy industrial motors are not acceptable.
- Capable of variable speed control for precise stitching
- Full metal, cast-iron, or industrial steel body and internal frame for long-term durability
- All major components, including hook and feed mechanisms, must be metal
- Machine bed must allow for smooth movement of heavy or large materials.

Included Design Features:

- Utilizes a double feed system consisting of top walking foot and bottom feed dogs
- Stitch length adjustable up to 9 mm
- Presser foot lift of at least 15 mm by knee lifter
- Capable of up to 2,000 stitches per minute
- Supports needles up to size 22 or larger
- Needle bar stroke must be at least 36mm

Accessories:

- Must include:
 - Table with cut-out
 - Bobbin winder
 - Standard presser foot
 - Cleaning tools (brush, oil, etc.)

Warranty:

- Ninety (90) day manufacturer's warranty to include labor, defects, and parts

- A. All bids submitted are subject to these instructions and general conditions and any special conditions and specifications contained herein, and in the terms and conditions of Resolution No. 136353 and/or Resolution No. 141125, all of which are made part of this bid proposal and ensuing contract by reference. By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law as well be in compliance with the Jefferson Parish Code of Ordinances ("JPCO"), Louisiana Code of Ethics, and applicable Jefferson Parish ethical standards.
- B. The General Conditions for construction projects (141125) and the General Conditions for the purchase of materials, services and/or supplies (136353) are those adopted by the Jefferson Parish Council by Resolution No. 136353 and Resolution No. 141125, respectively. The General Conditions adopted by these resolutions shall be considered as much a part of this document and the ensuing contract or P.O. as if they were written wholly herein. A copy of each may be obtained from the Office of the Parish Clerk, Suite 6700, Jefferson Parish General Government Building, 200 Derbigny Street, Gretna, LA 70053. - C. Jefferson Parish adheres to the Louisiana Code of Governmental Ethics, contained in La. R.S. 42:1101, et seq. Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law. Violation of the Louisiana Code of Governmental Ethics may result in rescission of contract, permit or licenses, and the imposition of fines and/or penalties, without contractual liability to the public in accordance with applicable law.
- D. All vendors submitting bids should register as a Jefferson Parish vendor if not already yet registered. Registration forms may be downloaded from <http://www.jeffparish.gov/464/Purchasing> and by clicking on Vendor Information. Current W-9 forms with respective Tax Identification numbers and vendor applications may be submitted at any time; however, if your company is not registered and/or a current W-9 form is not on file, vendor registration is mandatory. Vendors may experience a delay in payment if your company is not a registered vendor with Jefferson Parish.
- E. All quotations shall be based on F.O.B. Agency warehouse or job site (see Additional Requirements section), anywhere within the Parish as designated by the Purchasing Department. This provision does not apply to Public Works projects.
- F. Jefferson Parish requires all products to be new (current) and all work must be performed according to standard practices for the project. Unless otherwise specified, no aftermarket parts will be accepted. Unless otherwise specified, all workmanship and materials must have at least one (1) year guaranty, in writing, from the date of delivery and/or acceptance of the project. Any deviations or alterations from the specifications must be indicated on the bid form with bid submission. Supporting documentation may be required upon request.

- G. Bidders should submit all questions in writing via email to the Purchasing Specialist's email address as indicated above, no later than five (5) working days prior to the bid opening. The Purchasing Department will issue a written response to bidders' questions in the form of an Addendum. Please note that all official communication will be expressed in the form of an addendum.
- H. All formal Addenda require written acknowledgement on the bid form by the bidder. Failure to acknowledge any Addendum on the bid form shall cause the bid to be rejected. Jefferson Parish reserves the right to award bid to next lowest responsive and responsible bidder in this event.
- I. If this bid requires a pre-bid conference (see Additional Requirements section), bidders are advised that such conference will be held to allow bidders the opportunity to identify any discrepancies in the bid specifications and seek further clarification regarding instructions.
- J. JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR. Items bid must meet specifications. JEFFERSON PARISH WILL ACCEPT ONE PRICE FOR EACH ITEM UNLESS OTHERWISE INDICATED. Two or more prices for one item will result in bid rejection. Bidders are required to complete, sign and return the bid form and/or complete and return the associated line-item pricing forms as indicated. Vendors must not alter the bid forms. Doing so will cause the bid to be rejected.
- K. Written evidence of the authority of the individual signing the bid having such authority must be submitted with the bid. Failure to comply will cause bid to be rejected. AWARD OF CONTRACT: Jefferson Parish reserves the right to award contracts or place orders on a lump sum or individual item basis, or such combination, as shall in its judgment be in the best interest of Jefferson Parish. Every contract or order shall be awarded to the LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, taking into consideration the CONFORMITY WITH THE SPECIFICATIONS and the DELIVERY AND/OR COMPLETION DATE. SPLIT AWARDS MADE TO SEVERAL VENDORS WILL ONLY BE GRANTED TO THOSE DEEMED RESPONSIVE AND RESPONSIBLE.
- a. All bid prices shall remain valid for 45 days. Jefferson Parish and the lowest responsive and responsible bidder(s) by mutual written consent may mutually agree to extend the deadline for award by one (1) or more extensions of thirty (30) calendar day increments.
 - b. PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. Written protest must be received within 48 hours of the release of the bid tabulation by the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. (For more information, please see Chapter 2, Article VII, Division 2, Sec. 2-914.1 of the Jefferson Parish Code of Ordinances.)
 - c. PREFERENCE: Unless federal funding is directly spent by Jefferson Parish for this purchase, preference is hereby given to materials, supplies, and provisions produced, manufactured or grown in Louisiana, quality being equal to articles offered by competitors outside the state. "LSA – R.S. 38:2251-2261"
- M. USE OF BRAND NAMES AND STOCK NUMBERS: Where brand names and stock numbers are specified, it is for the purpose of establishing certain minimum standards of quality. Bids may be submitted for products of equal quality, provided brand names and stock numbers are specified. Complete product data may be required prior to award.
- N. CANCELLATION OF CONTRACT: JEFFERSON PARISH reserves the right to cancel all or any part if not shipped promptly. No charges will be allowed for parking or cartage unless specified in quotation. The order must not be filled at a higher price than quoted. JEFFERSON PARISH reserves the right to cancel any contract at any time and for any reason by issuing a THIRTY (30) day written notice to the contractor.
- a. For good cause and as consideration for executing a contract with Jefferson Parish, vendor conveys, sells, assigns and transfers to Jefferson Parish or its assigns all rights, title and interest in and to all causes of action it may now or hereafter acquire under the antitrust laws of the United States and the State of Louisiana, relating to the particular good or services purchased or acquired by Jefferson Parish.
- O. PRICES: Jefferson Parish is exempt from paying sales tax under La. R.S. 47:301 (8)(c). All prices for purchases by Jefferson Parish of supplies and materials shall be quoted in the unit of measure specified and, unless otherwise specified, shall be exclusive of state and local taxes. The price quoted for work shall be stated in figures no more than four (4) decimal points. In the event there is a difference in unit prices and totals, the unit price shall prevail.

INSTRUCTIONS FOR BIDDERS AND GENERAL CONDITIONS
