
Bid due date and time has been extended from 10/28/25 at 11:00AM CT to 11/4/25 at 11:00AM CT.

Supplier Inquiry and Response

- Q1. Can you please let me know if we will need a bid bond for this project and if there is a certain form to use?
 - A1. A bid bond is not required.
- Q2. Are we required to carry Builder's Risk Insurance for this project?
 - A2. See "Insurance Minimum Limits and Requirements for Standard Contractor/Vendor Agreements" included in the bid.
- Q3. Can you share the pre-bid sign in sheet?
 - A3. A sign-in sheet is not available for the non-mandatory pre-bid meeting.
- Q4. It looks like the deadline is October 28, is there time for me to submit a bid on this work? We would need to do site visits to quantify the extent of the work before submitting a quote.

A4. The bid due date and time has been extended from 10/28/25 at 11:00AM CT to 11/4/25 at 11:00AM CT. The specifications included information on a non-mandatory pre-bid meeting that was held on 10/16/25. There will not be another pre-bid meeting. Suppliers can submit a bid even if they did not attend the meeting.

Q5. For the Engineering Lab the marker on the document (pictured below) is on a building labeled as Facility Service Warehouse #2 on google maps. I went to campus to double check and found the larger building south of the warehouse is called the Engineering Lab Annex. Was the marker misplaced for the location of the Engineering Lab?



A5. The map shown above is labeled wrong. See attached correct map.

Q6. For the Tiger Habitat, there is a rock wall on the east side of the habitat that works as a wall to enclose that side of the habitat. Do you want the rock wall soft washed as well, or just soft wash the wall of the viewing area and the housing building with the tower?

A6. The rock wall is not included.

Q7. For the PMAC, the Practice Facility is connected to the Arena. Do you want the arena and practice facility soft washed or just the arena?

A7. The entire facility, which includes the practice facility and the arena.

Q8. For the Bernie Moore Track Stadium and Tiger Park Stadium, we were told not to wash the stadium seating. Just wanted to clarify, when it comes to the stadium seating areas are we still soft washing the walls, columns, stairs, ramps, etc. located internally of the seating

areas and not washing the seats themselves, or do you just want soft washing for everything external of the seating areas?

A8. This solicitation is for building washing only. Refer to "Areas to Be Cleaned: A-J" in specifications. Bleachers do not need to be cleaned. For this facility, the walls, columns, stairs and ramps internally are required to be cleaned.

Q9. For the Business Education Complex, the majority of the complex's walls is a glass exterior. In our experience soft washing will give a cleaner look to the windows but for heavy to extreme build-ups on the windows we would have to use brushes spraying filtered water to make them look spotless and that is a separate service to soft washing. Did you want the entire complex soft washed or just certain portions of the complex?

A9. The entire complex.

Q10. For the Landscape Services Building, there are two separate buildings on that lot (pictured below). Did you want to soft wash just the larger main building or do you want both buildings soft washed?



A10. Just the larger main building.

Q11. We are interested and will be placing a bid. I see that the pre-bid meeting has already passed so I was wondering if there is a way to do another walk through or find out the square footage combined for all building's so we can provide an accurate bid?

A11. The specifications included information on a non-mandatory pre-bid meeting that was held on 10/16/25. There will not be another pre-bid meeting. Suppliers can submit a bid even if they did not attend the meeting. Square footage information is not available.
