Questions from the Vendor and State's Responses:

Vendor Question 1. Could you please provide details such as prices, current vendor and terms.

State's Response: *The most recent contract was for 2023 calendar year. That contract was awarded to Barney's Inc. with a price of \$74.23 per pair of boots. See all current bid documents for terms that will govern this purchase.*

Vendor Question 2. How many employees are served under this contract?

State's Response: *This contract will not serve employees, these items are for the offender population.*

Vendor Question 3. Kindly provide us total expenditures incurred for the current contract for past 3 years.

State's Response: *The last contract for these items was originally awarded May 9th of 2022 for a price of \$74.23 per pair and the contract was renewed for the calendar year of 2023.*

Vendor Question 4. Do we need to have a local storefront in State of Louisiana in order to bid on this?

State's Response: *No, a local storefront is not required.*

Vendor Question 5. We are doing business in Miami Dade. Can we participate to this bid?

State's Response: *Yes, location of the vendor will not impact this contract.*

Vendor Question 6. Are the quantities for annual usage or for the full term?

State's Response: *The quantities are estimated for annual usage and will be ordered as needed.*
