Any bidder, regardless of whether bid is apparent low or not, whose bid contains patently obvious, unintentional, and substantial mechanical, clerical, or mathematical errors, who desires to withdraw its bid shall deliver to the Program Manager clear and convincing sworn, written evidence of such errors within forty-eight (48) hours after the time when bids are due for bid opening excluding Saturdays, Sundays, and legal holidays.

There will be a **NON-Mandatory Pre-Bid Conference and site visit will be held on November 6, 2025, 10:00 AM Local** in the 1st Floor Conference Room at the Baton Rouge Metropolitan Airport Terminal Building.

Each bid must be accompanied by a certified check, cashier's check, or bidder's bond in an amount equal to **five percent (5%)** of bid and shall be made payable to the City of Baton Rouge. Performance and Payment Bonds for the construction is required upon execution of the contract equal to one hundred percent (100%) of said contract amount.

There is no Disadvantaged Business Enterprise (DBE) goal set for this solicitation, but the BRMA encourages the use of DBE's certified under the Louisiana Unified Certification Program.

All Bidders shall comply with all provisions of the State Licensing Law for Contractors, R.S. 37:2150-2163, as amended and all shall comply with all requirements of the Specifications which are hereby incorporated into and made part of this Advertisement. It shall also be the sole responsibility of bidders to ensure that all subcontractors fully comply with applicable law and bidding requirements. All bidders shall hold an active license issued by the State of Louisiana Licensing Board for Contractors in the classification of **Highway, Street and Bridge** at the time of bid.

The City of Baton Rouge and Parish of East Baton Rouge reserves the right to reject any and all bids, and to disqualify any bidder, to the fullest extent allowed by law. In accordance with La. R.S. 38:2212, the provisions and requirements of law, those stated in this Advertisement for bids, and those required on the bid form shall not be considered as informalities and shall not be waived by any public entity.
