## PUBLIC NOTICE SOQ 25-039

### Provide a Consolidated Master Planning Effort for Laketown and the Esplanade Mall

The Parish of Jefferson, authorized by Resolution <u>No.147227</u>, is hereby soliciting a Statement of Qualifications (<u>General Professional Services Questionnaire</u>) from persons or firms interested in providing a consolidated master planning effort for Laketown and the Esplanade Mall.

### DEADLINE FOR SUBSMISSIONS: 3:30 p.m., November 6, 2025

That the Purchasing Department is hereby authorized to advertise for Statements of Qualifications from persons or firms interested in providing professional consulting services for the Parish of Jefferson for the preparation of a consolidated master planning effort for Laketown and the Esplanade Mall.

The following criteria shall be used to evaluate the Statements of Qualification the firms/individuals submit:

- 1. Professional training and experience in relation to the type of work required for the services (Maximum points awarded shall be thirty <u>30).</u>
- 2. Size of firm considering the number of professional and support personnel required to perform the tasks. (Maximum points awarded shall be ten 10).
- 3. Capacity for timely completion of the work. (Maximum points awarded shall be ten 10).
- 4. Past performance by person or firm on similar comparable projects identifying highest and best uses for commercial and coastline corridors, demonstrating an understanding of current private market potential, defining larger stakeholder group and public ambitions for development of these areas, and reconciling the public subsidy that may or may not be required to affect desired development outcomes (Maximum points awarded shall be 10).
- 5. Preference shall be given to persons or firms with a principal business office as follows: (1) Jefferson Parish, including municipalities located within Jefferson Parish <u>15</u> Points); (2) neighboring parishes of the Greater New Orleans Metropolitan Region, which includes Orleans, Plaquemines, St. Bernard, St. Charles and St. Tammany Parishes <u>12)</u> points); (3) parishes other than the foregoing <u>10)</u> points); (4) outside the State of Louisiana <u>6)</u> points). (Maximum points awarded shall be fifteen <u>15).</u>
- 6. Adversarial legal proceedings between the parish and the person or firm performing professional services, in which the parish prevailed or any ongoing adversarial legal proceedings between the parish and the person or firm performing professional services, excluding those instances or cases where the person or firm was added as an indispensable party, or where the person or firm participated in or assisted the public entity in prosecution of its claim. In the event that the person or firm fails to provide accurate and detailed information regarding legal proceedings with the parish, including the absence of legal proceedings, the person or firm shall be deemed unresponsive with regard to this category, and zero (0) points shall be awarded. (Maximum points awarded shall be ten 10) for the lack of any such adversarial proceedings as defined).
- 7. Prior successful completion of projects of the type and nature described, for which firm has provided verifiable references. (Maximum points to be awarded shall be fifteen 15).

The person or firm submitting a Statement of Qualification ((General Professional Services Questionnaire) must identify all subcontractors who will assist in providing professional services for the project, in the professional services questionnaire. Each subcontractor shall be required to submit a ((General Professional Services Questionnaire) and all documents and information included in the questionnaire. (Refer to Jefferson Parish Code Ordinance, Section 2-928)

All persons or firms (including subcontractors) must submit a Statement of Qualifications (<u>General Professional Services Questionnaire</u>) by the deadline. Submissions will only be accepted electronically via Jefferson Parish's e-Procurement site, Central Bidding at <a href="www.centralauctionhouse.com">www.centralauctionhouse.com</a> or <a href="www.jeffparishbids.net">www.jeffparishbids.net</a>. No submittals will be accepted after the deadline.

Affidavits and Insurance are not required to be submitted with the Statement of Qualifications, but shall be submitted prior to contract approval.

Disputes/protests relating to the decisions by the evaluation committee or by the Jefferson Parish Council shall be brought before the 24<sup>th</sup> Judicial Court.

## Statement of Qualifications Affidavit Instructions

- Affidavit is supplied as a courtesy to Affiants, but it is the responsibility of the affiant to insure the affidavit they submit to Jefferson Parish complies, in both form and content, with federal, state and parish laws.
- Affidavit must be signed by an authorized representative of the entity or the affidavit will not be accepted.
- Affidavit must be notarized or the affidavit will not be accepted.
- Notary must sign name, print name, and include bar/notary number, or the affidavit will not be accepted.
- Affiant MUST select either A or B when required or the affidavit will not be accepted.
- Affiants who select choice A must include an attachment or the affidavit will not be accepted.
- If both choice A and B are selected, the affidavit will not be accepted.
- Affidavit marked N/A will not be accepted.
- It is the responsibility of the Affiant to submit a new affidavit if any additional campaign contributions are made after the affidavit is executed but prior to the time the council acts on the matter.
