My understanding is that this would be contractually impossible, as Emerson-certified system integrators are required to maintain platform exclusivity and cannot hold certifications with competing vendors.

Would it be acceptable for us to submit a proposal supporting one or more of the listed platforms? Our team is highly experienced and certified with Siemens and Rockwell, and we are fully capable of supporting VT Scada, though we do not hold certifications with Schneider or Emerson products.
