- A. All bids submitted are subject to these instructions and general conditions and any special conditions and specifications contained herein, and in the terms and conditions of Resolution No. 136353 and/or Resolution No. 141125, all of which are made part of this bid proposal and ensuing contract by reference. By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law as well be in compliance with the Jefferson Parish Code of Ordinances ("JPCO"), Louisiana Code of Ethics, and applicable Jefferson Parish ethical standards.
- B. The General Conditions for construction projects (141125) and the General Conditions for the purchase of materials, services and/or supplies (136353) are those adopted by the Jefferson Parish Council by Resolution No. 136353 and Resolution No. 141125, respectively. The General Conditions adopted by these resolutions shall be considered as much a part of this document and the ensuing contract or P.O. as if they were written wholly herein. A copy of each may be obtained from the Office of the Parish Clerk, Suite 6700, Jefferson Parish General Government Building, 200 Derbigny Street, Gretna, LA 70053. - C. Jefferson Parish adheres to the Louisiana Code of Governmental Ethics, contained in La. R.S. 42:1101, et seq. Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law. Violation of the Louisiana Code of Governmental Ethics may result in rescission of contract, permit or licenses, and the imposition of fines and/or penalties, without contractual liability to the public in accordance with applicable law.
- D. All vendors submitting bids should register as a Jefferson Parish vendor if not already yet registered. Registration forms may be downloaded from http://www.jeffparish.gov/464/Purchasing and by clicking on Vendor Information. Current W-9 forms with respective Tax Identification numbers and vendor applications may be submitted at any time; however, if your company is not registered and/or a current W-9 form is not on file, vendor registration is mandatory. - E. All quotations shall be based on F.O.B. Agency warehouse or job site (see Additional Requirements section), anywhere within the Parish as designated by the Purchasing Department. This provision does not apply to Public Works projects.
- F. Jefferson Parish requires all products to be new (current) and all work must be performed according to standard practices for the project. Unless otherwise specified, no aftermarket parts will be accepted. Unless otherwise specified, all workmanship and materials must have at least one (1) year guaranty, in writing, from the date of delivery and/or acceptance of the project. Any deviations or alterations from the specifications must be indicated on the bid form with bid submission. Supporting documentation may be required upon request.

Every contract or order shall be awarded to the LOWEST RESPONSIVE and RESPONSIBLE BIDDER, taking into consideration the CONFORMITY WITH THE SPECIFICATIONS and the DELIVERY AND/OR COMPLETION DATE. SPLIT AWARDS MADE TO SEVERAL VENDORS WILL ONLY BE GRANTED TO THOSE DEEMED RESPONSIVE AND RESPONSIBLE.
 - a. All bid prices shall remain valid for 45 days. Jefferson Parish and the lowest responsive and responsible bidder(s) by mutual written consent may mutually agree to extend the deadline for award by one (1) or more extensions of thirty (30) calendar day increments.
 - b. PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. Written protest must be received within 48 hours of the release of the bid tabulation by the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing.  - c. PREFERENCE: Unless federal funding is directly spent by Jefferson Parish for this purchase, preference is hereby given to materials, supplies, and provisions produced, manufactured or grown in Louisiana, quality being equal to articles offered by competitors outside the state. - M. USE OF BRAND NAMES AND STOCK NUMBERS: Where brand names and stock numbers are specified, it is for the purpose of establishing certain minimum standards of quality. Bids may be submitted for products of equal quality, provided brand names and stock numbers are specified. Complete product data may be required prior to award.
- N. CANCELLATION OF CONTRACT: JEFFERSON PARISH reserves the right to cancel all or any part if not shipped promptly. No charges will be allowed for parking or cartage unless specified in quotation. The order must not be filled at a higher price than quoted. JEFFERSON PARISH reserves the right to cancel any contract at any time and for any reason by issuing a THIRTY (30) day written notice to the contractor.
 - a. - P. Section 2.0 - Scope:

We extend this proposal to provide all labor, materials, tools, supplies, and equipment necessary to provide a two (2) year contract to perform the following tasks (Parish-Wide):

- Painting, Coating, Priming, Staining, and Sealing
- Drywall Hanging
- Drywall Finishing
- Wallpaper Removal and Hanging

Section 3.0 – License/Certifications:

A Louisiana State Contractor's License will be required by LSA R.S. 37-2150 et. seq., and such license number must be entered in the appropriate field in the electronic procurement system.

Section 4.0 – Quantities/Inspection:

- To obtain bids, bidders shall provide a dollar amount for the quantity identified and listed in these specifications.
- Once the bid is awarded and during the contract period the successful bidder will be responsible to visit each project site and perform their measurements to determine the labor, materials, and equipment required to complete each project.

Section 5.0 – Bonds:

- **Surety Bond:** An Electronic Bid Bond in the amount of 5% of the total bid will be required with bid submission. The vendor shall indicate the electronic bid bond number in the location specified on the electronic bid envelope. No scanned paper copies of any bid bond will be accepted as part of the electronic bid submission.

- There shall be no minimum call-out time, work time, service time, etc., in terms of hours charged under the terms of this contract.
- Personnel arriving at the work site to perform services shall verify the start time by meeting with an owner's representative and signing in on an owner-provided log book.

NOTE- Failure to sign in with a parish representative may cause non-payment of the service invoice.

• Personnel departing from the work site shall verify departure time by meeting with an owner's representative and sign out on an owner-provided log book.

NOTE- Failure to sign out with a parish representative may cause non-payment of the service invoice.

 In case of excessive downtime, Jefferson Parish may provide an additional purchase order, not to exceed \$10,000.00, to the successful bidder to obtain the necessary part(s) to complete the repair work. Jefferson Parish will not allow any markup over invoice costs.

Section 6.1 Application of Coatings:

Products must be applied as per all manufacturer recommendations and guidelines.

The finished work will be uniform and of the approved color.

- It shall cover, be smooth, and free from runs, sags, clogging, or excessive flooding.
- Edges of coating adjoining other materials or colors shall be sharp and clear without overlapping.

Pigmented (Opaque) Finishes

- Completely covered to provide an opaque, smooth surface with uniform finish, color, appearance, and coverage.
- Imperfections will not be accepted.

Transparent (Clear) Finishes:

- Match-approved samples for color, texture, and coverage.
- A Jefferson Parish representative shall determine if all work meets quality standards.

6.2 Painting/Coating Priming, Staining, and Sealing of Various Interior and Exterior Surfaces:

- The Square foot or linear cost price for the painting, priming, staining, and sealing shall include all labor and equipment needed to properly prepare the surface before applying paint, priming, staining, or sealing, and must include:
- A minimum of one (1) coat of primer and two (2) coats top coat owner provided materials.
- Jefferson Parish will supply all paint, primer, stain, or sealant.
- Flatwork shall consist of, but is not limited to, walls, ceilings, floors, etc.
- Trim work shall consist of, but is not limited to, base, shoe moldings, ceiling moldings, cove moldings, chair rail, shelving, case molding, countertops, etc.
- Door and window units shall consist of, but are not limited to, doors, windows, frames, jambs, sills, trim, etc.

6.3 Drywall Hanging and Floating:

- The Square foot price for drywall hanging shall include tools and the necessary equipment to install drywall to a complete finish.
- Drywall shall be hung and finished per the manufacturer's recommended guidelines and industry standards for commercial buildings.
- The installed drywall shall not touch the floor to prevent wicking if the floors get wet.

6.4 Drywall Repair/Patching, Floating, Finishing, And Texturing:

6.8 General Laborer:

• The per-hour cost for a General Laborer.

6.9 – Project Estimator:

- Project estimator provides engineering planning, consulting, design, cost estimating, and construction management.
- The successful bidder shall provide insight and review planned projects to reduce cost and increase safety and efficiency. Provide and discuss any issues and concerns with the owner.

Section 7.0 – Hours/Days of Work:

All work shall be performed during days and hours as requested by the department. There are no extra charges for work performed after hours, on weekends, and during Parish holidays.

Section 8.0 – Cleaning & Safety:

The job site must be clean and free of all litter and debris caused by this work daily and upon project completion. Passageways must be kept clean and free of material, equipment, and debris. Safety precautions must always be exercised to safeguard the welfare and safety of the people while work is being performed.

8.1 Temporary Protection of Existing Facilities and Operations:

- Maintain egress within and around work areas.
- Before starting work on any area, provide the designated Jefferson Parish representative with a plan indicating how personnel moving through the area at ground level will be protected from the potential of falling materials.
- Provide temporary protection for adjacent areas and the work of other trades, whether to be coated or not, to prevent contamination during the coating's application.

The Jefferson Parish Purchasing Department would like to make vendors aware of the following changes that are now effective:

> Additional Requirements for Bid Instructions:

The Additional Requirements for Bid Instructions have been revised. The numbers correlating with the instructions may not be the same number as past bids. **Please read ALL instructions and bid documents carefully and thoroughly prior to bid submission.**

> Affidavits:

There is a new affidavit for all bids named "Generic Bid Affidavit". The Public Works Bid Affidavit and Non-Public Works Bid Affidavit are no longer valid. **The "Generic Bid Affidavit" must be submitted with ALL bid submissions.**

> <u>Insurance Requirements</u>:

Within ten (10) days of bid opening, the apparent low bidder will be required to provide <u>FINAL</u> insurance certificates evidencing the insurance coverages of the subject bid (please refer to each individual bid specifications requirements) to Jefferson Parish which shall name "the Parish of Jefferson, its Districts, Departments, and Agencies under the direction of the Parish President and the Parish Council" as additional insured on the Commercial General Liability and the Comprehensive Automobile Liability policies to protect against negligence by the contractor, as provided by contract.

Failure to provide your certificate of insurance within the ten (10) days of bid opening shall result in the Parish rejecting your bid as non-responsive and moving on to the next apparent lowest bidder.

You may still opt to send in your insurance certificates with your bid submission, however, if the provided certificates are not in FINAL form, if you are the apparent low bidder, then you will still be required to send in a FINAL certificate within 10 days of bid opening.

STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES

No individual partner, incorporator, director, manager, officer, organizer, or member, who has a minimum of a ten percent ownership in the Bidding Entity, has been convicted of or has entered a plea of guilty or nolo contendere to any of the crimes or equivalent federal crimes listed below. A conviction of or plea of guilty or nolo contendere to the following state crimes or equivalent federal crimes shall permanently bar any person or the bidding entity from bidding on public projects:

- (a) Public bribery (R.S. 14:118)
- (b) Corrupt influencing (R.S. 14:120)
- (c) Extortion (R.S. 14:66)
- (d) Money laundering (R.S. 14:230)

A conviction of or plea of guilty or nolo contendere to the following state crimes or equivalent federal crimes shall bar any person or the bidding entity from bidding on public projects for a period of five years from the date of conviction or from the date of the entrance of the plea of guilty or nolo contendere:

- (a) Theft (R.S. 14:67)
- (b) Identity Theft (R.S. 14:67.16)
- (c) False accounting (R.S. 14:70)
- (d) Issuing worthless checks (R.S. 14:71)
- (e) Bank fraud (R.S. 14:71.1)
- (f) Forgery (R.S. 14:72)
- (g) Contractors; misapplication of payments prohibited (R.S. 14:202)
- (h) Malfeasance in office (R.S. 14:134)

The five-year prohibition provided for in this section shall apply only if the crime was committed during the solicitation or execution of a contract or bid awarded pursuant to these provisions. If evidence is submitted substantiating that a false attestation has been made and the project must be readvertised or the contract canceled, the awarded entity

making the false attestation shall be responsible to the public entity for the costs of rebidding, additional costs due to increased costs of bids and any and all delay costs due to the rebid or cancellation of this project.
