Your reference is directed to RFx Number 3000025697 for the Invitation to Bid (ITB) for the State of Louisiana – Semi-Trailer - DOTD, which is currently scheduled to open at 10:00 AM CT on December 30, 2025.

Questions from the Vendor and State's Responses:

Vendor Question 1. Under section 1.4.1 Deck Features asks for Rumber composite rubber/plastic decking material. Would a wood deck be acceptable?

State's Response: *Wood would not be allowable.*

Vendor Question 2. Can we install paver-style ramps that would adjust inward a few more inches. It would close the gap to roughly 42".

State's Response: *A 42" gap is not acceptable. We don't just haul paving equipment. We haul a wide variety of equipment with this, so the full-width ramp is a requirement.*

Vendor Question 3. Can you please provide pictures of what a Powered full width ramp at the front of main deck looks like per 1.4.2 of the Speciation's documents.

State's Response: *Please see attached pictures per Attachment D - Photos.*
