TERMINATION FOR NONCOMPLIANCE:  
LSUHSC HAS THE RIGHT TO CANCEL ANY CONTRACT, IN ACCORDANCE WITH PURCHASING RULES AND REGULATIONS, FOR CAUSE INCLUDING BUT NOT LIMITED TO THE FOLLOWING:  
(1) FAILURE TO DELIVER WITHIN THE TIME SPECIFIED IN THE CONTRACT;  
(2) FAILURE OF THE PRODUCT OR SERVICE TO MEET SPECIFICATIONS, CONFORM TO SAMPLE QUALITY OR TO BE DELIVERED IN GOOD CONDITION;

#### 21. DEFAULT OF CONTRACT:

FAILURE TO DELIVER WITHIN THE TIME SPECIFIED IN THE BID WILL CONSTITUTE A DEFAULT AND MAY CAUSE CANCELLATION OF THE CONTRACT. It is anticipated that an award will be made to each supplier whose proposal represents a genuine value to LSUHSC, in overall price structure, product quality, known supplier performance, and in meeting the above required computer and performance standards. However, any award does not preclude LSUHSC from bidding out a particular need. A new item may be added at any time at an agreed upon price with the approval of the LSUHSC Purchasing Office. Identical items supplied by more than one vendor will be purchased from that vendor offering the lowest net price and meeting the delivery times needed.

**PERIOD OF AGREEMENT AND RENEWAL OPTION:**

The period of the Price Agreement shall be for one year from the date of award. The contract may be extended up to four (4) additional one year periods with the total term of the contract not to exceed sixty (60) months if agreeable with successful vendor and LSUHSC.

**SHIPMENT TERMS:**

Shipments are to be on the basis of FOB destination. Suppliers are expected to rush orders in at no additional cost when necessary to speed delivery time of orders which are delayed due to some error on the part of the supplier such as back orders due to low stock levels, incorrect shipments, delays in processing orders, et cetera. In some cases, the Scientific Supply Center staff will request 'Rush' shipments for reasons other than an error on the part of the supplier; in these cases, the supplier will have the option of adding shipping charges on a "pre-pay and add" basis. Collect shipments will not be accepted.

If supplier is not offering FOB destination, bid document must clearly state shipping terms and conditions. **If bidder does not enter specific freight terms on the submittal page, it will be assumed that freight is included in price and will ship F.O.B. destination and all freight charges will be included in the bid or quote price.**

**EQUIPMENT VERIFICATION:**

LSUHSC Scientific Supply Center research distribution outlet also purchases, on request, non-stock laboratory apparatus and equipment. Each vendor with a Net Price agreement will receive, via email, a "Current Pricing Request" indicating the item to be purchased. Vendors must respond indicating current pricing, which shall be verified against their bid to ensure that the discount applied is consistent with their submission. Failure to respond to a "Current Pricing Request" means that the vendor with a net price agreement does not have equipment to offer that is equivalent to that being priced at that particular time. **CONTRACT CANCELLATION:**

LSUHSC has the right to cancel any contract for cause, in accordance with purchasing rules and regulations, including but not limited to: (1) failure to deliver within the time specified in the contract; (2) Failure of the product or service to meet specifications, conform to sample quality or to be delivered in good condition; (3) misrepresentation by the vendor; (4) fraud, collusion, conspiracy or other unlawful means of obtaining any contract with the University; (5) conflict of contract provisions with constitutional or statutory provisions of state or federal law; (6) any other breach of contract.

LSUHSC reserves the right to cancel any contract for convenience at any time by giving thirty (30) days written notice to the vendor. In such cases, the vendor shall be entitled to payment for compliant deliverables in progress.
