THREE (3) YEAR CONTRACT TO PROVIDE A FULLY FUNCTIONAL DIGITAL CLOUD-BASED/ONLINE AUCTIONEERING SERVICES OF VARIOUS JEFFERSON PARISH-OWNED EQUIPMENT FOR THE JEFFERSON PARISH DEPARTMENT OF GENERAL SERVICES SURPLUS DIVISION

Section 1.0 - Scope:

We extend this bid for the successful bidder to provide all labor, materials, equipment, transportation, computer hardware, software, programming, written literature, and servers needed to provide a three (3) year contract to provide fully functional digital cloud-based/online auctioneering services for the sale of vehicles, equipment, office furniture, sporting goods, computers, and other miscellaneous items for the Jefferson Parish Department of General Services Surplus Property Division:

NOTE: Items to be auctioned do not include real estate or land parcels under this contract.

Section 2.0 – Bonds:

Section 2.1 - Performance

The successful proposer shall be required to provide a performance bond in the amount of ten thousand dollars (\$10,000.00) to ensure the successful performance of the agreement in accordance with the terms and conditions of the parties. The bidder acknowledges and agrees that the performance bond may be forfeited for the successful proposer's failure to fully and faithfully perform its obligations under the executed agreement. The performance bond shall be produced upon contract execution.

Section 2.2 - Bid Bond:

A bid bond of two thousand five hundred dollars (\$2,500.00) is due with the bid submission. The successful bidder must submit an electronic bid bond through the respective online clearinghouse bond management system as indicated in the electronic bid Solicitation on the Central Auction House. No scanned paper copies of any bid bond will be accepted as part of the electronic bid submission.

Section 2.3 - Fidelity Bond:

The successful proposer shall be required to provide a fidelity bond of fifty thousand dollars (\$50,000.00) to ensure Jefferson Parish is protected from fraudulent acts performed by the successful bidder and its employees. The proposer acknowledges and agrees that the fidelity bond may be forfeited for losses incurred due to dishonest acts by the successful bidder and its employees. The fidelity bond shall be produced upon contract execution.

Section 3.0 - License:

A copy of the front and, if applicable, the back of all license(s) listed below shall be provided upon request.

Section 4.0 – Insurance:

Section 4.1 – Cyber Liability Insurance

In addition to Jefferson Parish's standard insurance requirements for bidding purposes, the successful proposer shall be required to provide a Cyber insurance policy with a \$1,000,000 policy aggregate limit and a \$1,000,000 per incident limit for Data and Network Liability, a \$1,000,000 per incident limit for Media Liability, a \$1,000,000 per incident limit for Cyber Extortion, and a \$1,000,000 per incident limit for Privacy Breach Response Services. A 500,000 "Number of Notifications" Breach Response coverage limit, instead of a \$1,000,000 limit of coverage, can be substituted for Privacy Breach Response Services, subject to the proposer's Cyber policy structure. Cyber policy shall include coverage for Full Prior Acts.

Section 5.0 – Quantities:

There shall be no guarantee on the number of items sold throughout the thirty-six-month contract duration.

Section 6.0 – Specifications: FULLY FUNCTIONAL DIGITAL CLOUD-BASED/ONLINE AUCTIONEERING SERVICES

Auctioneering Company shall supply/provide the following:

- Provide all labor, materials, equipment, transportation, computer hardware, software, programming, written literature, peripherals, servers, and all other products and information required to provide a fully functional digital cloud-based/online auctioneering service to allow for the sale of various types of vehicles, equipment, office furniture, sporting goods, computers and other miscellaneous Jefferson Parish owned property.
- 24 hours a day, 7 days a week, 365 days a year online bidding.
- System shall be capable of adding, withdrawing, and canceling auctions without penalty to Jefferson Parish.
- Security system, anti-virus, and firewalls capable of preventing hacking of auction information.
- The vendor shall operate its own proprietary auction platform for this contract.

Section 6.0 – Specifications: FULLY FUNCTIONAL DIGITAL CLOUD-BASED/ONLINE AUCTIONEERING SERVICES Continued:

- Jefferson Parish will not pay for any costs associated with chargebacks and buyer fraud that may occur. The vendor must accept responsibility for chargebacks and buyer fraud that may occur.
- A technical resource to support the Parish with all aspects of the platform. This includes troubleshooting and general support of the platform. The successful bidder and the Parish will agree upon the Service Level Agreement (the Time it takes a successful bidder to resolve a trouble ticket) for outages and trouble ticket resolution.
- Any data requested by the Parish in a readable format. The successful bidder will securely retain data on behalf of the Parish in accordance with Parish retention policies.
- Standard Operating Procedures to include, but not limited to, the following:
 - Recovery of lost data
 - Security breaches
 - System failure
- On-site and online training and support of Jefferson Parish employees throughout the contract for the operation and maintenance of the services.
- Website shall be capable of loading and removing auction items at any time that best suits Jefferson Parish's needs.
- Monthly detailed financial and summary reports of all transactions to Jefferson Parish.
- Provide and absorb all costs of securing a host facility to operate the digital cloudbased/online auction system.
- System for collecting and processing payments from bidders that meets Payment Card Industry (PCI) data security standards to ensure companies process, store, or transmit credit card information securely. Jefferson Parish will not collect, process, or retain payment information.
- Provide training to Jefferson Parish staff as needed.
- System for setting reserve pricing (minimum price) on items.
- Auctioneer agrees to accept electronic payments, cash, or wire transfers.
- The auctioneering firm must collect all bid award payments within three (3) days of the close of each auction.
- All maintenance, upgrades, and security patches to the hardware, software, servers, peripherals, etc., for the length of the contract.
- All support and maintenance shall be available via email, online, and telephone to operate the auction site throughout the contract.
- Immediate notification of any cyber incident that could impact this service, including the data collected on behalf of the Parish.
- Maintenance and support shall be available between 8:00 a.m. and 5:00 p.m.
- Simple and uniform methods for bidders to submit bids and have the highest bid price posted on the bidding site for all bidders to view.
- Provide Jefferson Parish with the fair market value/cost of all items before items are placed out for bidding.
- Displaying the date and time the bid will end.
- Internal method of recording all bids, identifying the winning and the second-highest bidder.
- Internal method of processing complaints or disputes for bidding and payments.
- Jefferson Parish will not pay for freight or shipping of any items sold.

Section 6.0 – Specifications: FULLY FUNCTIONAL DIGITAL CLOUD-BASED/ONLINE AUCTIONEERING SERVICES Continued:

- Winning bidder of each item will have seven (7) working days to retrieve their items.
- After the seventh (7th) day, the item becomes the property of Jefferson Parish, and the bidder relinquishes all rights and payments of the item.
- Jefferson Parish will not pay for any title transfer charges.
- All items will be sold as is, where is.
- Appropriate staff to perform successful online auctions.
- Responsible for the collection of payment for all items sold.
- Fifteen days after each auction, provide a "monthly report" in Microsoft Excel containing the following information:
 - Description of each item sold.
 - Price of each item sold.
 - Date of each item sold.
 - Reserve the price of each item sold.
 - Plus or minus the awarded bid price for each item sold compared to the reserve cost.
 - Date each item sold was placed out for auction.
 - Duration of time each item was placed out for auction.
 - Second-highest bid on each item.
 - Name and country of origin of the winning bidder and the second-highest bidder for each item.
 - Description and length of time each unsold item has been listed on the auction site.
 - Total amount of all awarded bids.
 - Total amount of all items still out for auction.
- Jefferson Parish shall set all items' final reserve pricing (minimum price).
- A Microsoft Excel spreadsheet (collection tool) for loading assets to the website.
- Recommendations on items that have not sold after 60 days.
- Instructions and assistance on how to perform the following:
 - Insert descriptions and photographs of items on the site.
 - Payments from bidders are accepted.
 - Jefferson Parish will receive payments.
 - Items will be picked up from Jefferson Parish.

Section 6.1- Promotion and Advertising:

Auctioneering company shall perform and provide the following:

- Auctioneering firm shall provide monthly advertising of the availability of all items being auctioned at a minimum of once a month.
- All advertising shall be able to attract a minimum of fifty thousand viewers at any time
- For items valued at \$4,000.00 or greater, the successful bidder shall provide a marketing team to contact potential bidders who have expressed interest in specific items.
- Throughout the duration of the contract, the vendor must demonstrate its ability to
 drive higher auction sales results. The vendor shall use marketing plans, website
 traffic statistics, and recent sales comparison data. Vendor shall provide a monthly
 report (due on the 15th of each month) which details all efforts made.

Section 7.0 – Manner of Payment to Jefferson Parish:

Jefferson Parish shall receive a wire transfer or an ACH payment on the 15th day of each month for all items sold the previous month.

Section 8.0 –Awarding of Auctioneering Services Successful Bidder Bid:

A bid shall be awarded to the approved bidder as follows:

1. Bidder with the lowest cost charged to Jefferson Parish for all services associated with providing fully functional digital cloud-based/online auctioneering services as described in these specifications.

and

- 2. Bidder with the lowest percentage charged to buyer(s) (Buyer's Premium) for all purchases through the Jefferson Parish fully functional digital cloud-based/online auctioneering services, which shall include the following:
 - Cost of the item(s) purchased.
 - Auctioneers' cost for each item purchased.
 - Financial transaction cost.
 - Fees shall be passed through to the bidder entirely.

Section 9.0 – Permits:

If applicable, the bidder shall obtain permits as required by the Louisiana Auctioneers Licensing Board and Jefferson Parish.

The bidder shall be responsible for paying for these permits. All permits must be obtained before the start of the first auction.

Section 10.0 - Start of Work Conference and Notice to Proceed:


A "Start of Work Conference" shall be held between the successful bidder and the owner prior to any work commencing.

INSTRUCTIONS FOR BIDDERS AND GENERAL CONDITIONS

- A. All bids submitted are subject to these instructions and general conditions and any special conditions and specifications contained herein, and in the terms and conditions of Resolution No. 136353 and/or Resolution No. 141125, all of which are made part of this bid proposal and ensuing contract by reference. By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law as well be in compliance with the Jefferson Parish Code of Ordinances ("JPCO"), Louisiana Code of Ethics, and applicable Jefferson Parish ethical standards.
- B. The General Conditions for construction projects (141125) and the General Conditions for the purchase of materials, services and/or supplies (136353) are those adopted by the Jefferson Parish Council by Resolution No. 136353 and Resolution No. 141125, respectively. The General Conditions adopted by these resolutions shall be considered as much a part of this document and the ensuing contract or P.O. as if they were written wholly herein. A copy of each may be obtained from the Office of the Parish Clerk, Suite 6700, Jefferson Parish General Government Building, 200 Derbigny Street, Gretna, LA 70053. You may also obtain a copy of each by visiting the Purchasing Department webpage at http://www.jeffparish.gov/464/Purchasing and clicking on Online Forms.
- C. Jefferson Parish adheres to the Louisiana Code of Governmental Ethics, contained in La. R.S. 42:1101, et seq. Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law. Violation of the Louisiana Code of Governmental Ethics may result in rescission of contract, permit or licenses, and the imposition of fines and/or penalties, without contractual liability to the public in accordance with applicable law.
- D. All vendors submitting bids should register as a Jefferson Parish vendor if not already yet registered. Registration forms may be downloaded from http://www.jeffparish.gov/464/Purchasing and by clicking on Vendor Information. Current W-9 forms with respective Tax Identification numbers and vendor applications may be submitted at any time; however, if your company is not registered and/or a current W-9 form is not on file, vendor registration is mandatory. Vendors may experience a delay in payment if your company is not a registered vendor with Jefferson Parish.
- E. All quotations shall be based on F.O.B. Agency warehouse or job site (see Additional Requirements section), anywhere within the Parish as designated by the Purchasing Department. This provision does not apply to Public Works projects.
- F. Jefferson Parish requires all products to be new (current) and all work must be performed according to standard practices for the project. Unless otherwise specified, no aftermarket parts will be accepted. Unless otherwise specified, all workmanship and materials must have at least one (1) year guaranty, in writing, from the date of delivery and/or acceptance of the project. Any deviations or alterations from the specifications must be indicated on the bid form with bid submission. Supporting documentation may be required upon request.

- G. Bidders should submit all questions in writing via email to the Purchasing Specialist's email address as indicated above, no later than five (5) working days prior to the bid opening. Bid numbers must be mentioned in all requests. If submitting online, vendors may send questions via the E-Procurement site no later than five (5) working days prior to the bid opening. The Purchasing Department will issue a written response to bidders' questions in the form of an Addendum. Please note that all official communication will be expressed in the form of an addendum.
- H. All formal Addenda require written acknowledgement on the bid form by the bidder. Failure to acknowledge any Addendum on the bid form shall cause the bid to be rejected. Jefferson Parish reserves the right to award bid to next lowest responsive and responsible bidder in this event.
- If this bid requires a pre-bid conference (see Additional Requirements section), bidders are advised that such conference will be held to allow bidders the opportunity to identify any discrepancies in the bid specifications and seek further clarification regarding instructions.
- J. JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR. Items bid must meet specifications. JEFFERSON PARISH WILL ACCEPT ONE PRICE FOR EACH ITEM UNLESS OTHERWISE INDICATED. Two or more prices for one item will result in bid rejection. Bidders are required to complete, sign and return the bid form and/or complete and return the associated line-item pricing forms as indicated. Vendors must not alter the bid forms. Doing so will cause the bid to be rejected.
- K. Written evidence of the authority of the individual signing the bid having such authority must be submitted with the bid. Failure to comply will cause bid to be rejected. Acceptable written evidence may be a printout of the Louisiana Secretary of State's website listing the signatory as an officer or a manager. Such printout shall be included with the bid submission. Bids submitted by Owners or Sole Proprietorships must include certification that he or she owns the entity for which the bid is signed. This documentation must be submitted with the bid. - L. AWARD OF CONTRACT: Jefferson Parish reserves the right to award contracts or place orders on a lump sum or individual item basis, or such combination, as shall in its judgment be in the best interest of Jefferson Parish. Every contract or order shall be awarded to the LOWEST RESPONSIVE and RESPONSIBLE BIDDER, taking into consideration the CONFORMITY WITH THE SPECIFICATIONS and the DELIVERY AND/OR COMPLETION DATE. SPLIT AWARDS MADE TO SEVERAL VENDORS WILL ONLY BE GRANTED TO THOSE DEEMED RESPONSIVE AND RESPONSIBLE.
 - a. All bid prices shall remain valid for 45 days. Jefferson Parish and the lowest responsive and responsible bidder(s) by mutual written consent may mutually agree to extend the deadline for award by one (1) or more extensions of thirty (30) calendar day increments.
 - b. PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. Written protest must be received within 48 hours of the release of the bid tabulation by the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. (For more information, please see Chapter 2, Article VII, Division 2, Sec. 2-914.1 of the Jefferson Parish Code of Ordinances.)
 - c. PREFERENCE: Unless federal funding is directly spent by Jefferson Parish for this purchase, preference is hereby given to materials, supplies, and provisions produced, manufactured or grown in Louisiana, quality being equal to articles offered by competitors outside the state. "LSA R.S. 38:2251-2261"
- M. USE OF BRAND NAMES AND STOCK NUMBERS: Where brand names and stock numbers are specified, it is for the purpose of establishing certain minimum standards of quality. Bids may be submitted for products of equal quality, provided brand names and stock numbers are specified. Complete product data may be required prior to award.
- N. CANCELLATION OF CONTRACT: JEFFERSON PARISH reserves the right to cancel all or any part if not shipped promptly. No charges will be allowed for parking or cartage unless specified in quotation. The order must not be filled at a higher price than quoted. JEFFERSON PARISH reserves the right to cancel any contract at any time and for any reason by issuing a THIRTY (30) day written notice to the contractor.
 - a. For good cause and as consideration for executing a contract with Jefferson Parish, vendor conveys, sells, assigns and transfers to Jefferson Parish or its assigns all rights, title and interest in and to all causes of action it may now or hereafter acquire under the antitrust laws of the United States and the State of Louisiana, relating to the particular good or services purchased or acquired by Jefferson Parish.
- O. PRICES: Jefferson Parish is exempt from paying sales tax under La. R.S. 47:301 (8)(c). All prices for purchases by Jefferson Parish of supplies and materials shall be quoted in the unit of measure specified and, unless otherwise specified, shall be exclusive of state and local taxes. The price quoted for work shall be stated in figures no more than four (4) decimal points. In the event there is a difference in unit prices and totals, the unit price shall prevail.
 - a. Quantities listed are for bidding purposes only. Actual requirements may be more or less than quantities listed.

INSTRUCTIONS FOR BIDDERS AND GENERAL CONDITIONS

- P. ANTI- DISCRIMINATION: Bidders are not to exclude from participation in, deny the benefits of, or subject to discrimination under any program or activity, any person in the United States on the grounds of race, color, national origin, or sex; nor discriminate on the basis of age under the Age Discrimination Act of 1975, or with respect to an otherwise qualified handicapped individual as provided in Section 504 of the Rehabilitation Act of 1973, or on the basis of religion, except that any exemption from such prohibition against discrimination on the basis of religion as provided in the Civil Rights Act of 1964, or Title VI and VII of the Act of April 11, 1968, shall also apply. This assurance includes compliance with the administrative requirements of the Revenue Sharing final handicapped discrimination provisions contained in Section 51.55 (c), (d), (e), and (k)(5) of the Regulations. - Q. INSPECTOR GENERAL: It shall be the duty of every parish officer, employee, department, agency, special district, board, and commission: and the duty of every contractor, subcontractor, and licensee of the parish, and the duty of every applicant for certification of eligibility for a parish contract or program, to cooperate with the Inspector General in any investigation, audit, inspection, performance review, or hearing pursuant to JPCO 2-155.10(19). By signing this document, every corporation, partnership, or person contracting with PARISH, whether by cooperative endeavor, intergovernmental agreement, bid, proposal, application or solicitation for a parish contract, and every application for certification of eligibility for a parish contract or program, attests that it understands and will abide by all provisions of JPCO 2-155.10.

Failure to comply will result in the bid submission being rejected as non-responsive. The Parish reserves the right to award bid to the next lowest responsive and responsible bidder in this event.

<u>**DEDUCTIBLES**</u> - The Parish Attorney with concurrence of the Director of Risk Management have waived the deductible section of the Terms and Conditions for all Invitations to Bid, until further notice.

<u>UMBRELLA LIABILITY COVERAGE</u> - An umbrella policy or excess may be used to meet minimum requirements. If you are purporting to use an umbrella policy or excess to meet minimum requirements, then you must provide the Umbrella Schedule of Underlying Policies with the Certificate of Insurance evidencing which policies the Umbrella sits over.

FOR CONSTRUCTION AND RENOVATION PROJECTS: The following are required if selected below. Such insurance is due upon contract execution.

☐ OWNER'S PROTECTIVE LIABILITY

To be for the same limits of liability for bodily injury and property damage liability established for commercial general liability.

□ BUILDER'S RISK INSURANCE

The contractor shall maintain Builder's Risk Insurance at his own expense to insure both the owner (Parish of Jefferson) and contractor as their interest may appear.
