ADDENDUM NO. 01

Your reference is directed to RFx # 3000025763 for the Invitation to Bid (ITB) for the State of Louisiana – Deck Barge for LDWF, which is currently scheduled to open at 10:00 AM CT on 01/28/2026.

The following changes are to be made to the referenced solicitation:

RFx Currently Reads: Scheduled to open at 10:00 AM on January 28, 2026.

RFx Changed to Read: Scheduled to open at 10:00 AM on February 04, 2026.

Questions from the Vendor and State's Responses:

Vendor Question 1. What is the required horizontal length of the rake from the bow? Does the rake start at a specific frame (e.g., FR1) or a set distance from the forward plate?

State's Response: *There isn't a specified horizontal length of the rake or a set distance from the front plate, as long as it's not starting between FR1 and FR2 (must be equal to or forward of FR1).*

Vendor Question 2. The specs allow a 3/16" bottom plate but require 1/4" for sides and structural components. Should the bottom plate be increased to 1/4" to match the rest of the hull's durability?

State's Response: *The specs will remain as 3/16" minimum; vendors have the right to exceed the spec, but it must meet the minimum requested.*

Vendor Question 3. What are the required clear opening dimensions and locking requirements for the two watertight hatches?

State's Response: *No set dimension, but they are there for access, so they must be man-sized. Flush mount is preferred but not specified.*

Vendor Question 4. Does the Quintana Boat Launch have a crane available for offloading, or is the vendor responsible for providing mobile lifting equipment to launch the barge?

State's Response: *No crane on site; it will be the builder's responsibility to line up whatever is needed for launching.*

Vendor Question 5. Will the state consider milestone payments (e.g., at material procurement or hull completion) to help the shipyard offset initial mobilization costs?

State's Response: *No, the agency's policy is to pay in full upon receipt of the product.*

All else remains as on original Invitation to Bid.
