**Questions from the Vendor and State's Responses:**

**Vendor Question 1.** As this facility is not listed as a REMS dispensing location, can you provide confirmation/clarification that the facility is a REMS dispensing location, or if it is utilizing a dispensing pharmacy? We would need the pharmacy's name, address, and DEA number.

**State's Response:** *For nearly all REMS meds, which have their own registration, the vendors themselves must be registered to dispense the REMS med. Since the State is requesting a patient specific medication, the vendor (the filling pharmacy) and the prescribing doctor need to be registered with REMS. The prescribing doctor will complete all necessary registrations, as required.*

*Elayn Hunt Correctional Center's pharmacy is the end user (essentially, the patient). The State is not dispensing the drug, so the State does not have to register with REMS.*
