Questions & Answers

Q1. Item No. 1 – UD 12000 is no longer available with Flying Cross, do they want to pick something else or just want to submit what is the most comparable from Flying Cross (there are in my opinion a few options)? Opinion: There really should be an item for long sleeve and short since they are two prices and if you put the long sleeve price it is higher than the short sleeve so essentially two items would help save money. We see everyone that was using that us the following now:

- **Short Sleeve**
 - **Men – F185R78286**
 - **Women – F177R78Z86**
- **Long Sleeve**
 - **Men – F135W78Z86**
 - **Women – F1127R78Z86**

Does this shirt get embroidery (logo, name on one side, etc?) and how many patches go on this shirt?

A1. An approved equal can be bid; however, it will need a sample for evaluation. The shirts do not embroidery; each shirt has two (2) patches

Q2. Item No. 3-6 – What goes on front or back of jacket? Is it DTF?

A2. Nothing goes on the front or back of the jacket

Q3. Item No. 9 – Thorogood does not have a #834-6189 any longer. Do we just select the closest to it and suggest it? We have an alternate if so.

A3. You can specify an alternate as an approved equal for any item you are bidding; you will need to supply specifications for alternate item bid; agency may request a sample be provided for evaluation. The agency will make a decision as to whether or not it is acceptable.

Q4. Item No. 10-12 – Does this shirt get embroidery and how many patches go on this shirt?

A4. No embroidery; three (3) patches

Q5. Item No. 18-20 – Does this shirt get embroidery and how many patches go on this shirt?

A5. No embroidery; three (3) patches

Q6. Item No. 21-23 – Does this jacket have EMS on Back and what size and is it DTF? Does anything go on front of jacket such as DTF Logo?

A6. EMS goes on the back of the jacket, nothing on front. Lettering is 9.5” by 3”
