Your reference is directed to RFx Number 3000026450 for the Invitation to Bid (ITB) for the State of Louisiana – Waste Disposal Services for the Louisiana Department of Corrections (DOC, Elayn Hunt Correctional Center, which is currently scheduled to open at 10:00 a.m. CT on August 11, 2026.

The following changes are to be made to the referenced solicitation:

Addendum NO. 01, Vendor's Inquiry #4 and the State's Response #4 currently reads:

Vendor's Inquiry #4: For the existing 30 cubic yard compactor, is there a spare compactor available on site for equipment swaps, or should each compactor service be treated as a round-trip haul of the existing unit?

State's Response #4: The spare compactor on site is out of service. Therefore, each service should be handled as an equipment swap. The awarded contractor must bring an empty compactor to leave on site when removing the full unit, as a compactor must remain available at all times.

Addendum NO. 01, Vendor's Inquiry #4 and the State's Response #4 changed to read:

Vendor's Inquiry #4: For the existing 30 cubic yard compactor, is there a spare compactor available on site for equipment swaps, or should each compactor service be treated as a round-trip haul of the existing unit?

State's Response #4: Yes, there is a spare compactor available on site for equipment swaps. Therefore, each service should be handled as an equipment swap.

The Agency may occasionally request the successful contractor to bring a replacement 30 cubic yard compactor for use, if their compactor is unavailable.
